Besides, in agreement with the obligation of presenting a statement that supports GHG emissions reductions or removals retirement, BIOCARBON REGISTRY certifies assurance of the following requirements:

- a) Each credit emitted by BIOCARBON REGISTRY (VCC) is linked to a unique serial number, and in the registration system of BIOCARBON REGISTRY has a tracking system of GHG emissions reductions and removals and their retirement or cancellation;
- b) GHG mitigation Initiatives certified under the Standard follow guidelines of ISO 14064-2;
- c) Verification Results of all GHG mitigation Initiatives certified under the BIOCARBON REGISTRY STANDARD comply with ISO 4064-3 requirements;
- d) BIOCARBON REGISTRY only emits CCV for GHG mitigation projects that are certified by accredited Verification Bodies, under considerations given by the BIOCARBON REGISTRY STANDARD:
- e) BIOCARBON REGISTRY administrates a public registration platform, in which there are all GHG mitigation projects list, including their GHG emissions reductions and removals, and,
- f) Methodologies elaborated by BIOCARBON REGISTRY and other methodologies accepted by BIOCARBON REGISTRY include procedures for demonstrating and evaluating projects additionality, leakages risk, and non-permanence.
