

## **Verified Carbon Credits Retirement**

The BCR STANDARD® sets out the requirements for ensuring the integrity of GHG projects and guarantees that the calculation of mitigation results is complete, relevant, integral, reliable, comparable, consistent, accurate, transparent, conservative and avoids double counting

In the same way, and in accordance with the obligation to provide a statement of support for the retirement of Verified Carbon Credits (VCC), BIOCARBON CERT confirms that it fulfills the following requirements:

- a) Each VCC issued by BIOCARBON CERT is linked to a unique serial number, and in the registration system of BIOCARBON CERT has a tracking system of the VCC and their retirement:
- b) The GHG projects registered under BCR STANDARD PROGRAM follow the guidelines provided by ISO14064-2;
- c) The mitigation results of GHG projects registered by BIOCARBON CERT, meet the requirements stablished by ISO 14064-3;
- d) BIOCARBON CERT only issues VCC of GHG projects that has been verified by Validation and Verification Bodies accredited in the terms provided by the BCR STANDARD;
- e) BIOCARBON CERT has a public registry platform that lists GHG projects, including GHG emission reductions and removals, and;
- f) The methodologies approved by BIOCARBON CERT include procedures for assessing the additionality of GHG projects, as well as leakage and nonpermanence risk analysis.
