Present the following results:

1. The objective of the validation was to assess the conformity of the GHG mitigation project with the requirements of ISO 14064-2:2019 and validate it under the principles and criteria of ISO 14064-3:2019 standards, BCR Standard, version 3.4; and ACM002 methodology: Grid-connected electricity generation from renewable sources, version 22.0 requirements for the project PROYECTO SOLAR FOTOVOLTAICO DISTRIBUIDO DE LA PROVINCIA DE JUJUY - PERICO, which lasts for 7 años, validated for the crediting period 01/09/2024 to 31/08/2031.
2. The validation conducted by ICONTEC was based on information described in the report PROYECTO SOLAR FOTOVOLTAICO DISTRIBUIDO DE LA PROVINCIA DE JUJUY - PERICO, the team validated the requirements compliance, and obtained access to documents, processes, areas, records and information through the technical staff of Industrias Juan F. Secco SA.
3. Level of assurance is reasonable 95% and relative importance is 5% for the information reported in this statement, and is an integral part of the GHG MITIGATION PROJECT VALIDATION AUDIT REPORT issued by ICONTEC ⁽¹⁾
4. Total GHG emissions reductions validated by ICONTEC and expected by the Project are 92,052 tCO₂e for the crediting period: From 01/09/2024 to 31/08/2031.
5. The data and information provided by Industrias Juan F. Secco SA to the validation team are of a projected nature and with the evidence gathered during the on-site visit provide the inputs required to generate the statement.
6. The validation team concludes that the GHG statement reported by the project is free of material discrepancies and that the validation activities provide the level of assurance agreed at the beginning of the validation process.
