Project description	<p>The Project aims to reduce GHG emissions by implementing activities that avoid deforestation and forest degradation in a total of 803,497 hectares, while improving the quality of life of the communities of Buenos Aires, Cachiporro, Mutanacua, Puerto Morroco, San José del Cananari, Villa Gladis, Villa Real, and Altamira, ensuring the respect of social and environmental safeguards. The project's communities were properly identified and involved through various mechanisms to ensure their participation in all project's stages, in consequence, communities without gender segregation are beneficiaries of the project's productive activities due to the increase in incomes. In consequence, women take part in the project playing leadership roles. The activities of the project will contribute to the achievement of 3, 4, 13 and 15 SDGs. Finally, the project will generate during its lifetime the reduction of 64.460.237,3 ton CO2 eq. GHG emissions, with an average of 1.611.505,9 ton CO2 eq/year.</p>
